7 THE COURT: You may sit wherever you want now.
8 You're not bound by any particular seat, whatever makes you
9 the most comfortable.

10 All right. Ladies and gentlemen, you have now been
11 selected as the jury, and the clerk will swear the jury.

12 THE CLERK: Would you please rise and raise your
13 right hand.

14 (Jury sworn.)

15 THE COURT: Thank you. Be seated, ladies and
16 gentlemen.

17 All right. At this time, counsel for the plaintiff
18 may make an opening statement.

19 MR. RAPOPORT: Thank you very much, your Honor. If
20 it pleases the Court, I'll do exactly that, and counsel for
21 the defense.

22 Ladies and gentlemen, welcome to your jury service.
23 Let me be the first person to do that. And I'm going to be
24 using, for my comments this afternoon, some help from some
25 technology. So, you have televisions before you, and there's

1 a great big one behind me, although it's a little bit hard to
2 see.

3 The evidence will show a lot of things in this case,
4 and what I'm about to talk about is what the evidence is going
5 to show in the case. And it's my habit to try to start very
6 carefully with something that no one should agree with. The
7 evidence --

8 MR. BAYMAN: Your Honor, excuse me. I don't mean to
9 interrupt, but I think this is argument.

10 MR. RAPOPORT: I'm about to describe the central
11 point of what the evidence in this case is going to show.

12 THE COURT: Proceed.

13 MR. RAPOPORT: The evidence in this case is going to
14 show that prescription drug companies are required to tell
15 doctors what they know about the side effects of the drugs
16 they bring to market. When a prescription drug company does
17 not tell doctors what they know and someone is harmed as a
18 result, the drug company has to pay for the harm that they
19 cause.

20 Every witness that is knowledgeable about what the
21 duties of a pharmaceutical company is -- are in this case will
22 agree that prescription drug companies are required to tell
23 doctors what they know about the dangers of those drugs.
24 That's the whole purpose for having clinical trials.

25 Now, let me tell you the story of what GSK, sometimes

1 called SmithKline Beecham, what this pharmaceutical company
2 did in this case.

3 Now, first of all, we're talking about a drug, Paxil.
4 Paxil was first marketed in 1992, but for several years before
5 it was first marketed, there were clinical trials involving
6 Paxil. And you'll hear much more about what a clinical trial
7 is in this case, but for simple -- to start in a simple way,
8 it is using the chemical that's been developed and comparing
9 it with either something or a sugar pill, nothing, to see what
10 effect it's having on people.

11 And the document that I have in front of you here
12 shows that by 1989, from the clinical trials, the defendant in
13 this case knew about six suicides that happened. And here are
14 details. What I'm showing you here is an exhibit that the
15 Court has already admitted into evidence and which shows some
16 details about these suicides.

17 Now, I'm going to zoom this in so we can see it a
18 little bit better. And I'm going to use my highlighter to
19 show some of these. There's five of them right there called
20 up, and the other one is down a little bit further, right
21 here (indicating). You can see it there.

22 Now, I'm going to go back and forth between this
23 image and this one, which summarizes these -- five of these
24 deaths; and the reason I chose five of them is one of those
25 deaths happened a few days after the person stopped taking the

1 Paxil. I'm getting rid of that one for now. We'll talk more
2 about that one later.

3 Here are the five deaths that this defendant knew all
4 about. These documents come from their records. This is what
5 we have here.

6 There is a 58-year-old female who was on Paxil for
7 eight days who violently committed suicide by hanging herself.

8 There was a 42-year-old female on Paxil for 10 days
9 who committed suicide by overdose of a different drug.

10 There was a 56-year-old female on Paxil for seven
11 weeks who committed violent suicide by drowning.

12 There is a 50-year-old male in the third month on
13 Paxil who committed violent suicide by hanging.

14 There is a 58-year-old female in the fifth month on
15 Paxil who committed violent suicide by hanging.

16 Now, we're going to get into much more detail about
17 what else this defendant knew, but this defendant knew all of
18 that.

19 And certain things jump off the page. You'll hear
20 testimony in this case about suicide. Most people that
21 consciously choose to commit suicide do it in a way that they
22 perceive as painless. There is an 80 percent factor of
23 violence here.

24 Also, you'll here evidence that more men, by about
25 four times, commit suicide than women. Here, we have a lot of

1 women. Okay. The question arose in the clinical trials, what
2 is the connection between this drug and these suicides?

3 Let's go on. Oh, I want to -- before going on, I
4 want to come back to the first screen for a minute and talk to
5 you for a second about the one that happened after. You'll
6 see that -- let me see if I can just point it out to you here.
7 I don't draw such good circles, but you see there's an
8 18-year-old female who was on Paxil during the clinical trial,
9 but then who was six days off the Paxil when she committed
10 suicide. So, there actually were six suicides, but the sixth
11 one happened after she was off the Paxil.

12 And as you'll learn in clinical trials, you want to
13 compare apples to apples, and that's what we're going to be
14 doing in this case. And so I want to illustrate for you what
15 it means, exactly, to compare apples to apples.

16 So, first of all, more facts. GSK knew by 1989 that
17 in addition to the five suicides while people were on Paxil
18 that happened in the clinical trial, they had 40 human beings
19 who attempted to kill themselves while they were being treated
20 with Paxil in those clinical trials.

21 Now, a clinical trial has a go point. It's almost
22 like a horse race where you're picking people, so it doesn't
23 just start where it's you, you, you, and you, and you start
24 either taking a drug or getting a sugar pill in the blind.
25 That's not how it starts. They start by designing who they

1 want to study.

2 Then they have to collect people and make sure they
3 qualify. They have to make sure they're not on any other
4 drugs. And you come to a go point where -- it's called
5 randomization or baseline, where everybody is being compared
6 apples to apples.

7 Now, that's a very important concept. So, what
8 happened in these clinical trials? They didn't want the
9 people that were so depressed that they were ready to kill
10 themselves or on the verge of killing themselves. They were
11 studying people with depression and eliminating the ones that
12 were really close to killing themselves before they reach
13 baseline. That's what it's about.

14 So, what this is saying is these folks, after they
15 reached the baseline, they split them into groups; and one of
16 those groups got Paxil, and one of those groups got a sugar
17 pill. And neither knew which they were getting. That's how
18 that works.

19 So, more details on that later. Here's the statistic
20 that I want to get at, which is they knew about 40 suicides on
21 the Paxil, so the question comes up: How many happened for
22 the people that were on the placebo after the baseline
23 randomization occurred? And the answer there is one, which is
24 a little bit different than the answer for this group of
25 suicides. In the completed suicides, how many did they have

1 on the placebo? None.

2 So, between the suicides and the suicide attempts,
3 they had a total of 45, five suicides and 40 attempts, on the
4 drug, and one attempt on the sugar pill. That's what they
5 had.

6 So, this was a signal that this defendant knew about
7 of danger; and statistically speaking, comparing apples to
8 apples, which are the same people that were selected for the
9 study, they got to the start of the horse race, and then some
10 were given the sugar pill and some were given the Paxil, and
11 then they compared the group. A 760 percent increased risk of
12 suicidal behavior.

13 Now, there's another term that I'm introducing for
14 the first time. What is suicidal behavior? So, this means
15 that you try to kill yourself. It's either trying to kill
16 yourself or actually killing yourself. What is that compared
17 to? A suicidal thought. A suicidal thought is a different
18 thing. They can be connected, but they're not always. And
19 you'll hear evidence about how a lot more people have a
20 suicidal thought than ever act upon that suicidal thought; and
21 then, you know, some people act upon it, and it's people that
22 act upon it that are -- are doing suicidal behavior. That's
23 the most important thing.

24 So, 760 percent increased risk, meaning 7.6 times the
25 chance or the likelihood of suicide studied in the clinical

1 trials, known not from day one of the clinical trials, but
2 clearly known by the time the clinical trials were being
3 organized for reporting.

4 So, we had another signal, which is the combined
5 signal, I almost always refer to it. This is taking the 45
6 patients, and here, we have more data. So, you might wonder,
7 well, how many got the Paxil and how many got the sugar pill
8 after they reached the baseline and were randomized? How
9 many? And the numbers are right there.

10 And you don't have to remember these numbers. You'll
11 see them plenty of times during the trial. But in these
12 clinical trials, and this is around the time that they're
13 going to apply for approval to sell this drug, around this
14 time, it's 2,963 patients in the Paxil group and 554 patients
15 in the placebo group.

16 So, here, you can see that 45, or 1-1/2 percent, of
17 the people in the Paxil group either tried to kill themselves
18 or actually did. Now, when you look at statistics -- and
19 you'll hear evidence of various statistics in this case. One
20 of them that you'll probably hear is what is the -- how common
21 is suicide overall? And it's something like 8 out of every
22 100,000 people, which is way smaller than 1-1/2 percent.

23 And some of you are better with math than others, but
24 the bottom line here is that the signal is calculated easily.
25 Why do we say it's an 850 percent increased risk? And it's

1 not us saying this. There are scientists who will testify
2 about this. And everything I'm talking to you about today is
3 going to be from witnesses. I'll tell you about some of them
4 in more detail, about their qualifications and who they are.

5 But bottom line is when you combine the information
6 about the suicides and the attempts and then you look at how
7 many happened on placebo and you calculate the difference,
8 it's 8-1/2 times more likely, or 850 percent, increased risk
9 on Paxil.

10 Now, there is -- there are standards in this
11 industry. It's a regulated industry. The Food and Drug
12 Administration does the regulating; but, of course, the
13 evidence is going to show, the Food and Drug Administration is
14 not a pharmaceutical company. It's not the one that has the
15 obligation to do the clinical trials, to honestly report the
16 clinical trials, or to write the warnings. They are kind of
17 an oversight group.

18 So, the regulations governing that talk about: What
19 is -- what's a pharmaceutical company supposed to do? And the
20 law requires, as I put before you, and the evidence will show,
21 because his Honor is the person who will give you all of the
22 law, but the experts in this case will be testifying about the
23 do's and don'ts of being a pharmaceutical company, so it's
24 important even in the evidence to know something about the
25 regulations.

1 So, what's required here is the labeling has to
2 include -- it says, "Shall describe serious adverse
3 reactions." Every witness in this case will agree that
4 suicide is a serious adverse reaction. That you have to
5 report not only known safety hazards, but also potential
6 safety hazards; that the labeling has to be revised as soon as
7 a warning that there is reasonable evidence of an association
8 is known, and you don't have to wait until causation is
9 proved.

10 So, you'll hear testimony in this case from
11 regulatory experts that will explain to you that if there's a
12 doubling of risk, that is not only an association, but it's
13 causation. So, the kinds of risks that we're talking about
14 right from the start were multiples of what required a warning
15 under the law.

16 Here is another kind of board that takes the same
17 data we talked about and adds on the layer that I just
18 discussed. So, I think you already get the idea about
19 45-to-1, so it's really this other side here that I'm calling
20 attention to now, which is: Was there a reasonable
21 association with suicidal behavior and Paxil from the start?
22 The overwhelming testimony in this case, if not all of it,
23 will be yes, there was.

24 Was GSK obligated to warn right from the start that
25 Paxil in clinical trials had these results? Yes, they were.

1 Those warnings were required. And you will hear the testimony
2 of regulatory and other experts who know a great deal more
3 than I do about this topic from that witness stand about this
4 idea.

5 Who are some of these people? Well, this is what
6 some of them look like, and here's a little bit more detail
7 about the who's who and what's what of people you'll be
8 hearing from.

9 This guy here who I'm showing you is David Healy, a
10 world-leading expert on the SSRI class of antidepressants.
11 So, let's pause there again, and we're going to talk plain
12 English in this case. We're going to try hard not to play
13 alphabet soup and not to be confusing.

14 So, what's an SSRI? It's this class of drugs. Paxil
15 is one of the SSRI drugs. There was no such thing as an SSRI
16 drug before the late 1980s. Then what happened was this form
17 of antidepressant was invented and brought to market. There
18 are several different antidepressants in this category. Some
19 people may refer to it as antidepressants 2.0. It was more
20 advanced technology. So, it came on to stream call it 1990
21 for round numbers, and you'll have a general understanding
22 of it.

23 So, Dr. Healy is a medical doctor and a psychiatrist.
24 He is a professor of psychiatry from Wales. He is a past
25 secretary of the British Association of Psychopharmacology,

1 because some psychiatrists in addition to practicing, or
2 sometimes instead of, use their specialized knowledge on
3 things like drugs.

4 Dr. Healy has written over 200 peer-reviewed articles
5 and over 20 books, including the books I've listed on the
6 board here; and I won't take up our time together reading all
7 that because I know that you can read just as well as I can.

8 Dr. David Ross is a medical doctor with a Ph.D. and a
9 Master's Degree who is a former Food and Drug Administration
10 new drug evaluator with 10 years of experience who knows all
11 about the do's and don'ts of how companies like this defendant
12 should behave.

13 Dr. Roger Grimson is a Ph.D. mathematician
14 biostatistician and epidemiologist who we hope will be able to
15 testify in this case, but -- and who has provided a report
16 that our other experts will certainly rely on; but
17 unfortunately, Dr. Grimson had a stroke recently, and he does
18 live out of town, so it is questionable whether we will see
19 him. But you will certainly hear about him and hear about his
20 work.

21 There's Dr. Joseph Glenmullen, who is a psychiatrist
22 in practice -- educated and practice Harvard Medical School,
23 Cambridge Hospital 30-plus years as a psychiatrist, authored
24 numerous peer-reviewed articles.

25 These are examples of some of the people that you'll

1 be hearing from.

2 So, what else is there? Signals. When we talk about
3 signals, they don't get much louder than 7 or 8 times greater
4 risk from the very first clinical trials; and fundamentally,
5 all we're talking about here is: Do the doctors have a right
6 to know? This is not the kind of thing that we're talking
7 about how they advertise these kind of drugs. This is the
8 kind of thing we're talking about: Does the doctor have the
9 right to know? So, how else -- what else do we know about
10 statistics over the years? Because those clinical trials were
11 a long time ago.

12 This drug did go into the marketplace, and there's
13 data not only from those clinical trials but from other
14 ongoing clinical trials; and there's other information in
15 published medical literature because there are -- you know,
16 let's just say there are reasons why there's published medical
17 literature about suicides from this drug and others in its
18 class.

19 So, what do I have on here? I have images of some of
20 the exhibits in the case that are too small to read because
21 this is not the time to pull out medical journal articles and
22 read them in detail. But I have in red what comes out from
23 these particular sources of corroborating data that are from
24 2006 and I think are probably the most recent data.

25 So, the most important one of all is GSK's study.

1 So, GSK did a study that they concluded in 2006, and they
2 concluded that there was a 6.7 times increased risk from Paxil
3 even though they knew at the time that Paxil did not say on
4 it, "Hey, by the way, there's an increased risk of suicide."
5 Their statistic was for people who had Major Depression
6 Disorder, which they sometimes call MDD, and you may hear that
7 a little bit.

8 The federal government commissioned its own study
9 down here, this 2.76 number that I'm showing you; and that one
10 took some of the same data, but they looked at what they call
11 all indications. So, the question could come up, "Well, what
12 if somebody only had anxiety, that is, they didn't have
13 depression? How does the risk look for them?" So, taking all
14 comers, the federal government came up with an analysis, and
15 this is on suicidal behavior that we're talking about, 2.76
16 more likely from Paxil, among the worst performances, if not
17 the worst performance, in the entire class of drugs that we're
18 looking at.

19 So -- and then this other one is an article that was
20 published from an interesting study that you will hear
21 testified about that happened up in Ontario in the 2000s,
22 where a 5 times increased risk was found, but I'm not going to
23 dig into further detail about that study or any of the rest of
24 this work.

25 So, what should have happened in this case is

1 straightforward and is right here. What should have happened
2 is -- let's just get it nice and big so it can be read. What
3 should have happened is the suicide risks that were discovered
4 in the clinical trials should have been revealed to the
5 federal government and the doctors.

6 And if that had happened, then what would have
7 occurred is Paxil -- a Paxil-induced suicide risk would have
8 been revealed to the FDA and the doctors; and the result of
9 that would be that Mr. Dolin would never have been given any
10 Paxil, and he never would have died, which will be another
11 topic that I will talk about in some detail here.

12 But first, we need to look at a comparison between
13 what should have happened and what actually did. So, we have,
14 I think, an understanding -- we have an understanding of what
15 should have happened. Now let's see what did in fairly simple
16 terms.

17 Suicide risks that were discovered in the clinical
18 trials were not revealed to the FDA or the doctors. The data
19 was misrepresented instead. Those are big words, and those
20 are strong words, so I hope it won't surprise you to know that
21 I'm going to show you what backs that up next.

22 What happened? Paxil-induced suicide risk was not
23 revealed to doctors and has not been revealed to doctors fully
24 to this day. Now, there is a 44-page exhibit that somebody's
25 going to hold up in a minute that we call Joint Exhibit No. 1,

1 which is the 2010 version of the label. And if they don't
2 have it, they don't have to, because it's going to look
3 something like about the size of a pad of paper. Here we go.

4 So, this is a long, you know, detailed thing. And
5 it's not meant to be on the bottle. This one's dated June of
6 2010 from GSK. And it's not meant to be in the bottle, but
7 this is the information to the doctor. It comes out
8 periodically. For many, many years, these were published in a
9 book called the *Physicians Desk Reference*. Now that we're in
10 the electronic age, we see it more in electronic format.

11 But this is the warning label. And what does this
12 warning label, in all of its 44 pages, say about the risk of
13 Paxil-induced suicide for people who are 57 years old or for
14 people of any age above 24? It says nothing about that, zero.
15 Okay?

16 Now, for many years, if we look at my timeline, from
17 1991, when these misrepresentations were made about suicide,
18 until the mid 2000s, there wasn't a warning about the risk to
19 adults 24 and under or children. They didn't have that,
20 either. Okay?

21 In the 2000s, there was a big stink about that, and
22 there is now suicide risk warning for up to 24. But these
23 people have known that that risk has been there for people of
24 all ages, and it has not been put in the label.

25 So -- oops. Let us progress.

1 In 1989, as I mentioned earlier, that's when GSK
2 filed -- let me take a moment and define all of these names
3 going on. So, there were some mergers involved, and I think
4 everybody in the case is going to call the company GSK.
5 SmithKline Beecham is part of it. They are the people who did
6 this in '89 and who did everything we're talking about. So,
7 they're GSK, but you'll sometimes see in letters and other
8 things, SmithKline Beecham. You'll know that it's all the
9 same because those are mergers.

10 So, this is a moment in time, and it's when GSK has
11 applied to get Paxil approved for marketing as a prescription
12 drug in the United States. The ruling about whether to let it
13 happen or not had not occurred at this point, but something
14 fairly dramatic did, which was Dr. Teischer, and Dr. Cole, and
15 their co-author as well, Dr. Glod, were noticing with regard
16 to another drug, the first SSRI, Prozac, they were noticing
17 that it seemed like people were showing up in the medical
18 offices shortly after they start this drug with violent --
19 talking about doing violent death to themselves. And this was
20 alarming.

21 And these were very high-profile, very well-respected
22 doctors who raised the question that the drug may be causing
23 this and what's going on. I don't think that they were
24 involved in clinical trials of Paxil, but the environment
25 while the new drug application was pending was one of, "Hey,

1 wait a second. Are these drugs causing suicide? Is that what
2 is happening here?"

3 And the article didn't really answer the question.
4 It reported that this was being seen in medical offices and
5 that it should be dug into in greater detail.

6 So, that little bit of background is very important
7 to what happens next. So -- and this is one of the more --
8 well, I don't want to characterize it.

9 What happens? The FDA says, "You people, we want to
10 hear from you about this issue. We want to hear more about
11 your clinical trials. We want to hear more detail. We want
12 you to take a really good look at what's what."

13 And that effort concluded in late April of 1991, and
14 what I have here -- and I'm going to blow it up without all
15 the red arrows. What you have here is a letter dated
16 May 10th -- here you can see the May 10th right over here -- a
17 letter dated May 10th, 1991, and it is addressed to the
18 director of these kind of drugs over at the Food and Drug
19 Administration. And it is by the director of regulatory
20 affairs, Thomas Donnelly, Jr., Ph.D., from our defendant.

21 And what does this say, the part that I'm calling out
22 here? Let me really call it out. Quote, for our record, this
23 is GSK saying to the federal government in May of '91, quote,
24 "To summarize in brief, this analysis of data from prospective
25 clinical trials in depressed patients clearly demonstrates

1 that patients randomized to paroxetine therapy were at no
2 greater risk for suicidal ideation or behavior than patients
3 who were randomized to placebo or other active medication."

4 That is what this defendant told the federal
5 government; and that, ladies and gentlemen, I'm sorry for my
6 strong language, is a bald-faced lie.

7 MR. BAYMAN: Your Honor, there's no claim of fraud in
8 this case. This is really getting argumentative now.

9 THE COURT: Proceed.

10 MR. RAPOPORT: All right. Now let's go further.

11 The director's letter attached two little charts to
12 it that claimed that there were two placebo suicides and that
13 there were six placebo attempts in the clinical trial, even
14 though the evidence is going to show clearly in this case that
15 there were no placebo suicides after randomization and that
16 there was only one placebo attempt after randomization. And I
17 do not think that you will hear a single witness called by the
18 defendant to deny that fact. Okay?

19 But what do these charts show? They show that there
20 were more placebo suicides than there were, because two is
21 bigger than zero. And they show that there -- let me show you
22 where that is. Here's where they say placebo. They say there
23 were 554 people in the placebo group after randomization, and
24 two of them committed suicide. Except you know what? They
25 didn't.

1 And then we have this other piece for attempted
2 suicides, that's what the next part is. The top one was
3 actual suicides. And here you have their statement that on
4 the placebo, consisting of 504 people after the baseline,
5 after the randomization, six of them attempted to commit
6 suicide; but the truth is it was only one.

7 So, what's going on here? Well, the impact of this
8 change was -- there's a mouthful said here on this board, but
9 I'm going to go through this slowly. The impact of the change
10 was to lower the suicide attempt risk signal from 760 percent
11 more likely suicide on Paxil than placebo, to, hey, you know
12 what, placebo, you're more likely to have suicide on placebo
13 than Paxil.

14 And you might wonder, but it's five versus two and
15 how did you get that math? And the answer is because you had
16 around 3,000 people who took the Paxil, and you have around
17 550 people, whatever the exact number there is, 554 that took
18 the placebo. So, actually, two is a bigger number, if you can
19 follow that math.

20 And it doesn't even matter if you do follow the math.
21 The point is they flipped this. It's like a flip-flop. Okay?
22 They've got screaming signals of danger that the drug causes
23 suicide, and they flip it over to say, no, the sugar pill
24 causes more suicide. Come on. That's what they did.

25 And they did the same thing. This is the

1 significance. They flip-flopped this the same way with the
2 attempts, and the numbers are a little bit different. Let me
3 find it. Oh, no, it's the combined. I've got to get this
4 straight. The idea is the same. They flipped it upside-down
5 so the combined suicides and attempts were an 850 percent
6 signal that they flipped the other way and said, no, actually
7 two-and-a-half times more people die on the sugar pill. It is
8 false. It is false.

9 All right. So, let's go on. In the same letter,
10 which is an exhibit in evidence in this case, I believe, or
11 will be, on May 10th of '91, GSK's director of regulatory
12 affairs offered this explanation for the two claimed suicides,
13 for -- actual suicides. And they offered no explanation at
14 all for the six claimed placebos. But here's what they said.

15 And at first reading, this is really complicated
16 language, so we're going to have to break down some terms,
17 which I'm going to do immediately after we read this once.
18 I'm going to break down some terms, and then we're going to
19 come back and read it again.

20 So, what they say -- what GSK says to the government,
21 "Of the two suicides committed by patients randomized" -- and
22 you'll note that they put quotes on randomized -- "to placebo,
23 the method by which they took their lives was unknown." And
24 let's pause there for a minute. You've got people who killed
25 themselves, and unknown? But they say this. We've got two

1 dead people, and they were randomized to placebo. That's the
2 statement.

3 Then it goes on to say, "Although these patients were
4 actually participating in an active control study, the acts of
5 suicide were committed during participation in the placebo
6 run-in phase, and the specific points in time at which these
7 individuals took their lives were two days," with a negative
8 two in parentheses, "and 7 days," with a negative 7 in
9 parentheses, "prior to the baseline evaluation."

10 Now, the -- keep that in mind for a second while we
11 go and pick up some definitions and things so that we can
12 better understand what is being said there, and then we're
13 going to come back and take a closer look to how this adds up
14 to what happened in this case.

15 So, what is randomization? We talked about that a
16 little bit before and what is a run-in. So, the first thing I
17 want to do is discuss this visual aid that I'm putting up to
18 help with this a little bit.

19 So, we design a clinical trial. Those who run these
20 and will testify in this case, you design it. You pick who
21 you want to study. You recruit doctors to help you, and you
22 try to recruit patients to study. And then your goal is to
23 get to the point of randomization. You can see it here,
24 because in randomization, that's when you can actually begin
25 the comparison.

1 Up until then, you have this phase called run-in, and
2 the run-in is all about making sure that nobody reaches
3 randomization that doesn't belong there so it doesn't screw up
4 the apples-to-apples comparison. So, in getting this, this
5 piece of evidence explains run-in periods. And let me see if
6 I can get that so it's readable.

7 There we go. So, here it's explaining to us that
8 before patients enter a clinical trial, there's a run-in or
9 lead-in period of placebo. And I should add that you may
10 sometimes hear it referred to as a wash-out, although that's
11 not as precise because washing out other drugs is only one of
12 the things that happens in a run-in.

13 But in any event, there's no active treatment. There
14 is some dietary control. There's no active maintenance
15 therapy. You can kind of see that they're removing a lot of
16 things. And I'm not going to read all of that, but I want to
17 get to this list where it kind of lays out here some of the
18 things.

19 It acts as a wash-out period to remove effects of
20 previous therapy, meaning drugs.

21 No. 2, it can be used to obtain baseline data and to
22 evaluate if the patient fulfills study entry criteria.

23 Case in point, this study is meant to exclude people
24 that are really close to suicide because that would mess up
25 the whole study. So, one of the central purposes of the

1 run-in period is to make sure that nobody gets past the
2 randomization goal line that's real close to suicide.

3 Then you have it can be used as a training period for
4 patients and investigators and their staff if the clinical
5 trial is just getting going.

6 It helps identify placebo responders. What's a
7 placebo responder? So, some people, you may give them a sugar
8 pill, and they may tell you, "Man, I feel a lot better.
9 Everything is good now." And you want those people out of the
10 study because you want people to have enough anxiety or enough
11 depression that, you know, it's not so likely that just
12 telling them they're taking a pill, even though there's
13 nothing in it, is going to make them all better. That's what
14 a placebo responder is. You want to get rid of them, too.

15 And useful information about patient compliance, so,
16 I mean, the point is during the run-in, people are excluded;
17 and when we get to randomization, that's when the study
18 starts. So, that's what is randomization. That's what is a
19 run-in.

20 And what is baseline, it's really closely tied to the
21 randomization idea; and as you can see here, we need to get to
22 baseline for these various reasons and the reasons that were
23 on the other presentation, too.

24 So, now, let's look at this again and get down to
25 what did the top guy dealing with regulators at the

1 defendant's company say here in this? Did he reveal this?
2 Didn't he reveal it? And after this, we'll see to what extent
3 there's evidence that the FDA heard it if they didn't uncode
4 this.

5 So, first of all, you have this business of the two
6 suicides committed by patients randomized to placebo. So,
7 that part of the statement is incorrect because there were no
8 patients that committed suicide that were randomized to
9 placebo. And the author of that letter to the FDA had to
10 know it.

11 Then it said, "We don't know the method that they
12 killed themselves." That raises a question fundamentally
13 about whether there even were two people that killed
14 themselves on placebo. But we have no evidence -- we can't
15 prove that they didn't have two people that killed themselves
16 on placebo. We've just seen precious few details about it,
17 and a pretty big motive, the evidence will show, for perhaps
18 making it up altogether; but we're not making that accusation.

19 MR. BAYMAN: Objection.

20 MR. RAPOPORT: I'm not making that accusation.

21 MR. BAYMAN: That's argumentative. He just said
22 motive, and then he said he had no evidence.

23 THE COURT: Stick to the evidence.

24 MR. RAPOPORT: So, the evidence is in front of us
25 here, and what else did this top person at GSK in the

1 regulation field tell the government?

2 He said, "Although these patients were actually
3 participating in an active control, the acts of suicide were
4 committed during the placebo run-in." And then he says, "It
5 happened so much before we reached baseline." So, what we
6 should do is credit the last part of this for revealing a fact
7 that the federal government certainly -- that it was their
8 duty to reveal if they were going to play around with data
9 like this.

10 So, now let's go further. The -- I wanted to add,
11 they had more data by '91, or at least they analyzed the data;
12 and what you see on this board are charts, and you'll hear, I
13 think, Dr. Glenmullen testify about this. This is a way of
14 unraveling the statistics. We kind of talked about this
15 already. This is showing the difference between including and
16 not including the run-ins that they were claiming. So, that's
17 just showing -- both of these boards are showing the math for
18 a point that we really already covered.

19 But here is the thing. The FDA approved Paxil for
20 marketing in the United States on January 1st of 1992. There
21 is no evidence that GSK submitted a warning telling people
22 what had been learned in the clinical trials about suicide
23 behavior risk, and here's what the FDA final report said.

24 They wrote down here, "Two patients randomized to
25 placebo committed suicide," which is an incorrect statement.

1 They do not in that particular report say anything about these
2 being in the run-ins. And the tables -- we'll see this
3 momentarily, but the tables that were presented and I showed
4 you briefly before showed that these were after randomization.
5 Okay? And the FDA clearly thought that these suicides were
6 after randomization because they said it in their report.
7 They got it from GSK.

8 Next it says -- the FDA put -- and this is all from
9 Plaintiff's Exhibit 28 in evidence as pages 29 and 31. "Six
10 placebo-treated patients attempted suicide," which is, as I
11 say, a misleading statement, because the fact is that the six
12 patients referred to did those attempts during a run-in phase,
13 so they were never in the post-randomization clinical trial.
14 The FDA does not comment about that, and nothing in GSK's
15 submission even told the FDA about that.

16 The number -- and that's very significant, by the
17 way, because even without the two suicides that were slid in
18 there, the attempts alone give a huge signal. So, they have
19 run-in attempts and didn't reveal that to the FDA at all.
20 They had two suicides, where in some fine print, they
21 referenced that these were in run-in; but in other places
22 they're saying -- in the same place, they're saying it's post
23 randomization.

24 The number and incidence of the rates of suicidal
25 acts and attempts are summarized in Table 55. This is what

1 the FDA says, and these tables do not mention a single thing
2 about the run-ins that completely alter the data because the
3 evidence will show that the FDA didn't know about it.

4 Then it says here, this last bullet point, "These
5 analyses show that patients randomized to paroxetine were at
6 no greater risk for suicidal ideation or behavior than
7 patients randomized to placebo or other active-control
8 therapies," when it should have said that there was this
9 seven- to eightfold increased risk discovered in the clinical
10 trials.

11 That is a verbatim adoption of the statement by GSK's
12 top regulatory guy to the FDA in 1991 as if that were real
13 instead of a fiction.

14 All right. So, here is the table just discussed,
15 Table 55. Look at this table, and you'll see this again
16 during the trial. The table lays out the two run-ins, but
17 does not reveal that they're run-in suicides. And the table
18 lays out the attempts, but does not reveal that those were
19 attempts.

20 And the bottom line on this table is there is a
21 remarkable piece of evidence that you'll see, because if
22 you'll remember, all of this we're talking about in '91, in
23 '89 was when they made the new drug application. And at the
24 start with the new drug application, they have the same table,
25 but a little bit different. There, it has asterisks on it

1 that say, "Two of these suicides and six of these attempts
2 happened during the run-in phase."

3 So, in the years between '89 and '91, that
4 disappeared. While under scrutiny from the Teischer article
5 about suicide, all of a sudden, GSK is presenting a table that
6 completely miscategorized two people who probably killed
7 themselves in the run-in phase, and all of those people who
8 did attempts that were in the run-in phase.

9 So, it's a funny thing. You know? We wouldn't
10 normally make a big thing out of an asterisk, but I will tell
11 you that during the course of our days together, you'll hear
12 about an asterisk and understand that it's not merely an
13 asterisk that we're talking about. We're talking about
14 completely flipping the results from an increased risk of
15 suicide to, "No, it's not."

16 All right. I'm not sure if you will hear any
17 witnesses in this trial tell you that it's okay to include
18 run-in attempts or run-in suicides in an analysis like this;
19 but you're going to hear from a lot of people, if not
20 everybody that's knowledgeable -- and here's the list of
21 people. The one next to GSK, Dr. J. P. Garnier, CEO at the
22 time he testified, of GSK, will admit that. So will Christine
23 Blumhardt, who was the person who was the leader in 1989 when
24 the new drug application was done.

25 You will hear that. You will even hear that from a

1 doctor whose name is Dunbar who will call himself the chief --
2 he doesn't say cheerleader, but he's the person from GSK who's
3 promoting Paxil to the world. And he puts out articles after
4 articles about how there's no suicide risks, it's even good
5 for suicide, and says nothing about the known increased risk,
6 and instead complete -- keeps repeating these same tables that
7 have false data in them.

8 And when questioned about this years later, you will
9 hear the -- I believe you will hear the remarkable testimony
10 from him that says, "I didn't know. No one told me. I didn't
11 know."

12 All right. So, we're back to we have these signals.
13 They needed to be reported to doctors because doctors can't do
14 their job. They weren't reported to doctors. That, we have
15 reasonably well covered already.

16 So, what does GSK have to say about all of this?
17 You'll see -- you'll hear evidence of a few different things
18 from them and from us. And we believe that we will show the
19 various points that are listed here. There's only seven. I
20 actually think by the time it's over, we're going to prove
21 13 different ways that they -- sometimes in what looks like a
22 sloppy manner and sometimes in a very devious manner, how this
23 signal has been covered up and not given to doctors for all of
24 these years.

25 So, one of the ways I talked about at great length

1 already about including run-ins. One of the ways is an
2 emotional ability label. So, instead of labeling suicide
3 attempts as suicide attempts, many of them were put into
4 coding in these clinical trials under a vague term that, you
5 know, makes you wonder. And it was only after there was major
6 scrutiny on some of the suicide risks that some of these
7 suicides we now know about came to light.

8 I want to say a word or two about this third thing,
9 including studies 057 and 106. So, when they came under
10 pressure under the juvenile thing in the 2000s and were sort
11 of fighting the fight to not have a warning for --

12 MR. BAYMAN: Objection, your Honor. Again, this is
13 argumentative. "Fighting the fight to not have a warning"?

14 THE COURT: Yes. Just tell the jury what you think
15 the evidence will show.

16 MR. RAPOPORT: So, here's what I'm getting at with
17 studies 057 and 106. These -- what are they? There were two
18 studies where the selection criteria went for depressed people
19 that were at real high risk of suicide. In other words, most
20 of the studies were set up to not go for those people, but
21 then they did some studies to study that cohort, if you will.

22 And as you might expect, there was more suicide in
23 those two cohorts. So, at some point, GSK moved down the path
24 of trying to include those because the people getting the drug
25 were very carefully monitored; but people were at a very high

1 risk, and so there were more suicides, apparently.

2 You'll hear about that issue. That issue was not in
3 play until the 2000s, and our center of focus really is in the
4 1998, '99 area. But you'll hear about it, so I wanted to
5 comment about it here. And you'll hear about these other
6 techniques as well.

7 But I think so that we don't get too deep into the
8 forest and we stay at the -- too deep into the trees and we
9 stay at the forest level, I'm going to move forward a little
10 bit here and keep this moving.

11 So, this chart is an interesting sort of chart. It
12 shows, both with suicides and attempts, the cluster of these
13 in the early form of treatment -- in the early times of
14 treatment. So, there's a certain pattern that you can see for
15 the attempts, and to some extent, for the suicides, where they
16 tend to come on very quickly with the therapy.

17 And you'll hear the Juurlink study in Ontario, which
18 had a million patient years under it and is probably the
19 richest study that you'll hear about it in the case. You'll
20 hear that it found that the greatest risk was in the first
21 30 days of the treatment and that the hallmark characteristic
22 of the suicide was extreme violence, though not in every case,
23 but those are kind of a hallmark pattern.

24 Here is an example -- I mentioned Dr. Dunbar before,
25 so here's an excerpt from Plaintiff's Exhibit 34, which

1 highlights a published statement in December of '91 that says,
2 "Suicides and suicide attempts occurred less frequently with
3 paroxetine than either placebo or active control." That was
4 not a correct statement.

5 Same thing in '92, this one by Christine Blumhardt,
6 "There's no evidence that this increases suicidal ideation."

7 Over time, there was more data. As you can see here,
8 the numbers went up to 4,126 people, so the analysis goes on,
9 but it's still a 750 percent risk in '94 for -- and the
10 combined risk 840 percent, the first one being attempts and
11 the second one being combined attempts and completed. In
12 2002, there was even more data, and this is the lowest that
13 their signal ever got, which is 2.38.

14 And these numbers, you know, different studies,
15 different numbers of people get different amounts of risk.
16 So, what the evidence will show that we're watching for is
17 risk at 2 or so or above. They were consistently there on
18 suicide and suicide attempts signal, suicide behavior
19 throughout the combined signal in 2002. The best it ever got
20 was 361 percent.

21 Here you can see for yourself, this is the 6.7, they
22 call it an odds ratio, and what this is telling us is that
23 results in 2006 by GSK for suicide attempts in adults with
24 depression, MDD-type depression, treated with paroxetine
25 compared to placebo, that the risk is 6.7. So, an odds ratio

1 is another way of showing the percentages I've been showing.
2 6.7 is the same as 670 percent risk or 6.7 times more likely.

3 So, this just goes back to '89, because there's a
4 peculiarity, and I did want to touch upon this before moving
5 further forward, which is in '89, strangely enough, when they
6 first submitted data, they actually had 42 people on attempted
7 suicides instead of 40. We never have found out, and maybe
8 we'll find out during the trial, what happened to those other
9 two. We're not saying that's the center of everything. It's
10 not, but we're just pointing it out.

11 So, you will hear evidence from a very well-qualified
12 psychiatrist in Dr. Glenmullen, that -- proof -- about proof
13 that Paxil causes suicidal behavior, and it gets down to these
14 three categories.

15 Since 1989, the Paxil clinical trial data has
16 signaled a statistically significant and substantial increased
17 risk of suicidal behavior in patients of all ages taking Paxil
18 compared to placebo.

19 Second, that GSK researcher causality assessments
20 have concluded Paxil has caused suicidal behavior on many
21 occasions.

22 And third, published medical literature establishes a
23 statistically significant and substantially increased risk of
24 suicidal behavior in patients of all ages taking Paxil
25 compared to placebo and other antidepressant medications.

1 So now, this is what I call my transition board, and
2 gives Matt Sims a signal, because for the next part of my
3 presentation, I'm going to use a slightly different manner of
4 communicating visually.

5 But what we have here, I think you'll recognize, is
6 the board that -- okay. Well, we switched. We just had the
7 board that I showed at the outset showing the five suicides in
8 the clinical trial and how they happened, the different ages
9 of people, how they were hangings and drownings, except for
10 one overdose. And then sadly, I added a picture of Stewart
11 Dolin and wrote, "57-year-old man on Paxil for six days,
12 violent suicide by subway train."

13 Now, that tells you one of the stories that this case
14 involves, the story of what GSK did. A second story that will
15 be involved here is a little bit about what has happened in
16 the medical profession, especially with general practitioners,
17 as it relates to antidepressants in the last 25 years.

18 So, you will hear testimony in this case from
19 Dr. Sachman, who is a family practice doctor based in the
20 northern suburbs, who has lived in this community for the
21 better part of his life and has been practicing family
22 practice medicine for many, many years. You will hear from
23 him about his education and how he was educated as a doctor in
24 the late '70s, and he practiced starting in the late '70s and
25 through the '80s, '90s, thousands, '10s, and -- I guess we're

1 in the '10s, so practiced all that time.

2 And you'll hear about the change that has occurred,
3 because GSK and other companies that manufacture the SSRIs
4 have really taken these things and marketed them to general
5 practice doctors because in the early years of Dr. Sachman's
6 practice, when he had somebody that was -- had some anxiety,
7 they weren't treating that with medications. If somebody was
8 bad enough, there would be a referral into mental health
9 professionals. And for the most part, antidepressant
10 medications were not being handed out by family practice
11 doctors the way that they are today.

12 That has something to do with this lawsuit, and you
13 will hear evidence about the obligation of a pharmaceutical
14 company to tell the general practice doctors that they're
15 pitching this stuff to about the dangers and not to hide those
16 dangers. That is not a controversial idea in this case. So,
17 that's a second story.

18 Now, I'm going to bring to you the third story here,
19 and I'm pretty sure that you know what that story is going to
20 be. So, the timeline of Stewart Dolin's life is not easy to
21 share. I guess we'll just -- the timeline of his life is not
22 easy to share on a simple timeline. As the trial goes along,
23 we will help you.

24 We, you know, heard loud and clear about how you
25 don't have notes, and this case is -- it's well to digest the

1 way the Court has suggested; but we will help by not only
2 making sure that people speak plain English, but by bringing
3 you charts and other things so that you can follow these dates
4 and times.

5 And if I was to do a proper job -- you'll pardon
6 me -- if I was to do a proper job of timelining what I'm about
7 to, I would need a timeline that would be bigger than this
8 courtroom. So, today's technology, though, gives us the
9 ability -- I think we've all walked in to museums that have
10 that kind of giant timeline, and you can look at one thing at
11 a time and then step back and see the timeline, and that's
12 what we're going to do.

13 So, Stu Dolin was born in 1952 in Chicago. He went
14 to Senn High School. He was a football player there. While
15 on vacation, he met a cheerleader from Sullivan that he didn't
16 know. And for those of you that know the Chicago area, you
17 may know these schools. Otherwise, these are two high schools
18 on the North Side of Chicago, not that far away from each
19 other. Sorry.

20 So, anyway, Mr. Dolin graduated in 1970. He followed
21 Wendy -- they were dating by then -- down to the University of
22 Illinois. She was a year older. And so, they were married in
23 '74. Stewart went to law school. Wendy graduated the
24 University of Illinois, and a year later Stewart graduated the
25 University of Illinois.

1 Stewart went to law school at Loyola. He got a
2 summer associate job at a nice law school in Chicago, which is
3 a good thing. It indicates that he did very well at Loyola,
4 because those jobs are sort of precursors. Unlike a law
5 clerk, someone who has a summer associate job is being told,
6 you know, "If everything works out, we're going to hire you
7 when you get out of law school," and that's what they did.

8 So, he graduated in 1977. He passed the bar exam on
9 his first attempt and began practicing law in 1977 at that
10 firm that he had clerked, stayed there for several years.
11 During this time frame, his son -- their son Zachary was born.
12 You'll meet Zack.

13 He was continuously employed as an attorney, and a
14 productive one, from the day that he got his law license.
15 Actually, before he got his law license, he was employed. He
16 just couldn't be a lawyer until he got his ticket. But he
17 practiced law full-time from that day forward until the day
18 that he died. And there is no evidence in this case that he
19 ever lost a single day from work for anything having to do
20 with mental health.

21 So, this -- Bari, so they have two kids, Zack and
22 Bari, there you see Bari born in 1983. And here you see that
23 after several firms, including starting his own -- so the way
24 this worked at the start is the first firm hired him. Then he
25 was recruited out of there by Fox & Grove, which is a fancy --

1 well, I shouldn't say fancy, but it's a fancy firm in Chicago.
2 Then he and three or four other people started their own firm
3 for a period. That accounts for the first 12 years of his
4 practice.

5 And in 1989, he began his career that he really had
6 for the rest of his life at the fine law firm of Sachnoff &
7 Weaver, a firm of substantial size here in Chicago. He worked
8 at that firm continuously, and it merged into another law firm
9 called Reed Smith, a worldwide major law firm. When it merged
10 in, he merged in with it; and at the time of the merger, I
11 believe that he was chair of the business department of the
12 Sachnoff Weaver firm.

13 By all measures, you will hear evidence that this guy
14 was a nice guy, smart, a great personality, a good lawyer,
15 very well-liked by his clients and others that he came to deal
16 with, in addition to being an outstanding father and husband
17 and friend.

18 Now, you're going to meet this gentleman who I spoke
19 about a little bit earlier, so let me tell you a little bit
20 more. I already told you about Dr. Sachman's qualifications,
21 but I didn't tell you about Dr. Sachman's personal
22 relationship with the Dolins.

23 So, Dr. Sachman, a well-established family practice
24 physician by 2004 of many years of experience, was also
25 friends with the Dolins. And Mr. Dolin came under

1 Dr. Sachman's care as a family practice physician in 2004 and
2 remained under his care from that point forward until the time
3 of his death.

4 The evidence will show that many times, family
5 practice physicians, in fact, treat family members and
6 friends. The evidence will show that there is no ethical
7 prohibition of that, and that's what occurred in this case.

8 So, we have now -- I'm going to focus in more on
9 Mr. Dolin's health situation and mental health situation, so
10 the evidence that I'm about to show and through the remainder
11 of this session is mostly a distillation of the medical
12 records that are in evidence and the pharmacy records that are
13 in evidence because I want you to see all of the facts. And
14 I'm doing my best within a reasonable amount of time to give
15 you all of the facts that will be proved in this case.

16 So, the visit in '04 was just a well visit. Annual
17 physicals are in here, and Mr. Dolin was feeling fine.
18 Mr. Dolin had no significant known health problems.

19 So, in '05, though, Dr. Sachman prescribed Paxil for
20 the first time, and he did this and Mr. Dolin was on it for
21 about a year there of 10-milligram Paxil, and you'll hear
22 Dr. Sachman's testimony about how Mr. Dolin --

23 MR. BAYMAN: Your Honor, excuse me. He was on
24 10 milligrams paroxetine, not on Paxil.

25 THE COURT: All right.

1 MR. RAPOPORT: He's on 10 milligrams of paroxetine,
2 which is another name for Paxil. Sometimes it's the generic
3 form; sometimes it's not. But as his Honor told you already,
4 that has nothing to do with the issues that are involved in
5 this case.

6 So -- and the reason for that is you will hear
7 evidence and understand that it was GSK, this defendant, that
8 developed this drug, that sets the warnings for this drug, and
9 that writes the label for this drug that is used by everyone
10 else. You will hear evidence that it is foreseeable to GSK
11 that people who get Paxil might get Paxil or might get a
12 generic, and whether it's a generic or not has nothing to do
13 with this.

14 So, in any event, what I was trying to talk about was
15 Dr. Sachman put Mr. Dolin on paroxetine and had him on it, in
16 retrospect, for a year at that point in time. You will hear
17 the testimony from Dr. Sachman about why he did that, which
18 had to do with some anxiety that Mr. Dolin was experiencing.

19 Now, to understand this clearly, at this point in his
20 life, Mr. Dolin had not had any mental health treatment that
21 we know of. He had not had a mental health diagnosis. He was
22 not diagnosed at that point with depression. He was -- he had
23 not missed any time from work. He had not had any suicidal
24 thoughts. He had not had any suicidal actions.

25 He was, you'll hear evidence, experiencing some

1 anxiety, and you'll hear all about that. But this is really
2 the start of the story of antidepressants in this case.

3 You'll also hear evidence that at the time that this
4 prescription was made, that Dr. Sachman had no idea that there
5 was increased risk of suicide for some patients that take
6 Paxil. You'll hear his testimony that if he knew that, he
7 would never have prescribed any paroxetine or Paxil.

8 You'll also hear evidence by the way that in
9 Dr. Sachman's records, he frequently refers to the drug as
10 Paxil. So, speaking the word "Paxil" is totally consistent
11 with the evidence in this case.

12 So, anyway, we go on from here. He was on.
13 Dr. Sachman saw him and noted that he was feeling fine. Here
14 are some pictures showing -- and you will see, because his
15 Honor has allowed into evidence an 11-or-so-minute video
16 montage that really kind of shows Mr. Dolin's life from
17 childhood through late in his life. I'm not going to show
18 that today. That will be shown during the evidentiary phase.
19 But what we have here are some clips taken out of that just to
20 give you a flavor of what we're talking about.

21 So, here, you can see him in his warmth, and that's
22 his daughter, wife, and son in approximately 2006.

23 He stopped taking the paroxetine. Dr. Sachman felt
24 he was generally fine. And our timetable here is the death
25 occurs July 15th of '10. So, we are a few years before that.

1 Now, this was around -- 2007 was around the time of
2 the merger between the substantial Chicago firm and the
3 substantial international firm. Oh, I skipped a part which
4 was important there, which was he was at times a chair and at
5 times a co-chair of the U.S. Corporate and Securities Group,
6 which is a group of lawyers at that law firm.

7 So, meanwhile, around this time, Mr. Dolan comes
8 under the care of Sidney Reed, a social worker. He comes
9 under her care in February of '07, and he sees her
10 periodically, including the night before July 15th of 2010.

11 So, Ms. Reed is an experienced social worker. She is
12 based in Evanston; but we have had a misfortune, so -- she has
13 had a misfortune associated with her health. But she has --
14 it's going to prevent her from being at the trial; but she has
15 given a video -- a videotaped deposition of her testimony, so
16 you will hear from her. But because of her health problem,
17 she can't be here. And that happens sometimes.

18 I should comment that some of the evidence you will
19 hear, maybe a considerable amount, as it turns out, will be by
20 videotape deposition because some people are beyond the
21 subpoena reach of the Court, and some examples of that are
22 some of the GSK employees that are former employees. So,
23 you'll hear testimony, and his Honor will explain to you that
24 testimony is testimony, whether it's in person or whether it
25 was given out of court and played to you in video form.

1 So, in any event, you'll hear from Sidney Reed. So,
2 this is a summary of care, so he came in there anxious about
3 the merger and with fears of being able to do the job without
4 some strong mentors; that in this time frame, you can kind of
5 see the dates and sort of see, I won't read every one of
6 these, but in February of '07, she's seeing him with some
7 frequency, and he is expressing fears and concerns that I've
8 put on the board here about feeling that his life is totally
9 different in the new firm and some fears that this may have
10 him stop functioning. This is all chronological. We're just
11 moving forward in time. Sidney Reed was encouraging him to
12 exercise and do deep breathing.

13 At no point throughout her care did she ever feel it
14 necessary to make a referral to a psychiatrist. She was
15 working with him, and you'll see that he has ups and downs
16 with what he's struggling with.

17 Here, they were talking about his fears and traced
18 the development of his stress and origin of his fears, and the
19 evidence in this case will show that he had no -- you know,
20 some of us have horrible, horrible things that occur to us in
21 our childhoods. We may have some of this ourselves. We may
22 have this with somebody we know. That's not Stewart Dolin.
23 There's no evidence that he was ever abused as a child. There
24 is no evidence that he had any illegal drug problem or use.
25 There is no evidence of alcoholism. There is no evidence of

1 lack of performance in the workplace in a meaningful way.
2 There is no hospitalizations for psych issues or anything like
3 that.

4 So, these origins are all in Sidney Reed's testimony,
5 and you'll hear about it; that he's had insecurities; that
6 he's cut off from his brother, and you'll hear more about
7 that; that he wants or needs to contain his anxieties.

8 And during this time frame, Dr. Sachman put him on
9 Zoloft, and you can see that he put him on 50 milligrams. And
10 milligrams are going to matter here in a minute, and I'll show
11 you why.

12 So, meanwhile, Sidney Reed is reporting that his wife
13 has always been a cheerleader, that he got good feedback from
14 his boss. She's helping him try to keep things in
15 perspective. That's what's going on here in the summer of
16 '07. We're roughly about three years away from what happened.
17 That he had feelings at times of not being a winning person on
18 the team.

19 And there's much more in these records, but these are
20 highlights that are an attempt to show what were the problems
21 at different points in time.

22 He was caught up in a triangle with his wife's
23 sister, but brightening up a little bit and seeing some new
24 opportunities to bring in business in late July of '07.

25 Here is a reference to his mother passing away in

1 '06, to the fact that there was this merger, to the fact that
2 he had an assignment in Pittsburgh that he felt shy and
3 inexperienced about, but it seems to be going well.

4 You'll hear evidence that he was a very sophisticated
5 lawyer, but he hadn't practiced international law before; and
6 his firm had just merged into an international firm, and he
7 had a big job, and he had concern. He had concerns about
8 that, in spite of the fact that his performance was generally
9 very good, if not excellent.

10 He had concerns about no longer being his own boss
11 because a bigger company had come in. He was feeling better
12 in later summer of '07, feeling much better by the fall of
13 '07.

14 But at around this time, there was a doubling of the
15 dosage of the Zoloft, for reasons that Dr. Sachman will
16 explain. And it's not 100 percent clear. The doubling
17 prescription was written in October of '07, but there was
18 probably a phase-in period, so he probably didn't start taking
19 the Zoloft then until a month or so -- the increased dose
20 until a month or so later.

21 But in any event, he's doing better by late October
22 of '07, as you can see. He's really starting to almost get
23 over this bout and feeling really good in late November --
24 early November of '07.

25 And then here we have an entry that I'm sure you'll

1 hear discussed at length during the trial. It says here that
2 he's feeling very depressed and down. It says, "suicidal
3 thoughts." Now, this is the first time that there is any
4 reference to any suicidal thoughts in any of Mr. Dolin's
5 records. Ms. Reed will tell you about it. She testifies
6 about it.

7 She examined these thoughts carefully. They appear
8 to be relating to wanting to escape pressure at work. He had
9 no plans of suicide and calmed down after talking about the
10 situation and how he could handle it. And he was looking
11 forward to seeing his kids for the holiday.

12 So, Sidney Reed will explain that she was keeping a
13 close eye on that, but was not concerned because she felt
14 these were passive thoughts and because of what happens next.

15 So, he's seen by Dr. Sachman and fine shortly
16 after -- again, I'm sorry, this is just kind of what he's
17 looking like in that time frame. And he's feeling very good.
18 By the time she sees him next, he's explaining he's doing very
19 well at work. He's laughing. He laughed when he was reminded
20 that he once expressed a fear of becoming a bag lady.

21 At some point, he had a fear like that, and Sidney
22 Reed, you'll hear her testimony, is going, "Wait a minute.
23 You're an elite partner in a major law firm. You've missed no
24 time from work. You're doing just fine. What do you mean bag
25 lady?" But he was worried that that was something that he

1 really at least talked about once, but in January of '08, he's
2 looking back and laughing at that, back to his old self and
3 fine.

4 And you will hear testimony about the increased
5 dosage of Zoloft and the connection between that one-time
6 mentioned suicidal thought with no plan. You'll hear an
7 opinion by a psychiatrist that that's the most likely cause of
8 that.

9 MR. BAYMAN: Objection, your Honor. This is the
10 subject of a motion *in limine* with respect to Zoloft and a
11 ruling by the Court.

12 THE COURT: Well, you can state what you think the
13 evidence will be.

14 MR. RAPOPORT: Okay.

15 So, the -- here, you have this reference in February
16 of '09, back to himself. March of '08, things going well.
17 March of '08 in the doctor's office for a cough and otherwise
18 seeming fine.

19 And throughout this, the social relationship between
20 the Dolins and the Sachmans, they are friends as couples, and
21 so a month wouldn't go by when they weren't together socially
22 as well. So, Dr. Sachman knows Stewart -- knew Stewart, and
23 knows Wendy Dolin very, very well.

24 And so we keep going here. Sidney Reed, we're now
25 spring of '08, and there's some talk about the sister, and

1 you'll hear that whole story.

2 Here, Mr. Dolin comes off of the Zoloft. That's June
3 of '08, about two years before the events that bring us here.

4 Here in June of '08, he's ready to stop sessions, got
5 through the hopelessness, survived, more careful, more
6 sensitive to other people, promises to call if she's needed.

7 And then we go forward now. There's just the
8 evidence of Zoloft again. Dr. Sachman will explain all of
9 that. Here he's doing very well in December of '08. Here,
10 he's decreasing weight, which is a good thing. That was part
11 of the medical recommendations and doing well.

12 Here's one of my favorite images. I never had a
13 chance to know Mr. Dolin, but here, you can see the face of
14 depression. So, there -- and you will see -- you will hear
15 evidence in this case when we get to it that for the most
16 part, people interacting with Mr. Dolin had no idea that he
17 was having these anxieties. I'm not talking about what his
18 wife knew. We'll get to that. But to the outer appearances,
19 he really seemed just fine.

20 So, hernia problem. It's just there for
21 completeness. Here, he's off of the Zoloft in May of '09.
22 Here, he sees his doctor for an annual physical in December of
23 '09. Now we're getting closer in time to what brings us here,
24 feeling just fine.

25 Here, he saw Sidney Reed. He hadn't been seeing her

1 much, but he sees her for one visit, and it's the only one
2 that's going to happen even for five months after this; but he
3 had some concerns actually about an overdue debt from a
4 friend, and not sure how to work with that. But that's what
5 that visit was about.

6 He had a vaccination. And he's back to see Sidney
7 Reed in May of 2010 and talking a little bit now again about
8 work stresses. He's not sure that he wants to continue as
9 head of the leadership group.

10 Now, you'll hear evidence in the case that explains
11 that in law firms, they're measuring time worked, and
12 sometimes what you do to manage is not necessarily valued in
13 the same way. It can get complicated. And he's -- there's --
14 the evidence is that he's considering to what extent he wants
15 to continue being in a managerial role versus doing more legal
16 service, you know, delivering the service to people.

17 So, anyway, his father-in-law is declining. It's May
18 of 2010. He was highly anxious. He had a visit in June of
19 2010, but this was a highly stressful time in the family due
20 to the impending death of Mr. Dolin's father-in-law, to whom
21 he was very close.

22 Around this time, Dr. Sachman writes a prescription
23 for Zoloft, but will testify that Mr. Dolin didn't feel well
24 from this. So, on June the 27th -- and let me not get ahead
25 of myself. First June the 26th. So, on June 22nd of '10,

1 there's a Sidney Reed visit where Mr. Dolin again expressed
2 the fear of failure, pointed out that the last year had been
3 his best financially, yet he was feeling depressed. Said he
4 was getting medication from his doctor because that had helped
5 the last time. So, that's the situation as of June 22nd.

6 Now, on June 27th, Mr. Dolin stopped taking the
7 Zoloft, and it was at this time that Dr. Sachman prescribed
8 the 10 milligrams of paroxetine that Mr. Dolin began taking,
9 although he was instructed to wait until the Zoloft was out
10 of his system. And by virtue of a medical record I'll go over
11 shortly, we know exactly when it was that -- we know exactly
12 when it was that Mr. Dolin started taking the paroxetine,
13 which was July the 10th. And I'll show you momentarily why we
14 know this.

15 But here's a new player. So, June 29th, Mr. Dolin
16 started seeing a Ph.D. psychologist who did behavioral
17 therapy. That's who Dr. Sahlstrom is. Dr. Sahlstrom has
18 moved to another part of the country, so her testimony will be
19 by video deposition as well, but she sees him for the very
20 first time and writes a couple of things down.

21 She did a clinical interview. He had long-standing
22 feelings of some work insecurity. He had no history of
23 depression or suicidal ideation or attempts. Prognosis is
24 good. She assessed the trauma history, the leisure time,
25 friends and family history, and wanted to see him again in a

1 week.

2 So, at that visit, this is documentation and
3 Dr. Sahlstrom's testimony that Mr. Dolin probably had no
4 memory of any brief moment of a suicidal thought. The other
5 possibility is he chose not to tell her, but --

6 MR. BAYMAN: Your Honor, this is speculation now.

7 THE COURT: Sustained. Just tell the jury what you
8 think the evidence will show.

9 MR. BAYMAN: I'd ask the jury to disregard that.

10 THE COURT: That may go out, right. The jury will
11 disregard it.

12 MR. RAPOPORT: So, anyway, the fact is that on
13 June 29th of 2010, Stewart Dolin told Dr. Sachman that he had
14 never had suicidal thoughts and that he was not feeling
15 depressed.

16 And the fact is that he didn't have an official
17 depression diagnosis, though clearly, he was feeling anxiety
18 and some bad -- feeling in a bad way enough to see Sidney Reed
19 for all of these times that we've looked at.

20 So, this is what happened. She recorded and will
21 testify that his prognosis was good. She assessed his trauma
22 history and didn't find any big, you know, horrible trauma
23 like sometimes people have. That she's -- you know,
24 understands that his leisure, friends, and family are all
25 good.

1 So, she --

2 THE COURT: All right. Mr. Rapoport, we're going to
3 take a recess now. And, ladies and gentlemen, we'll take a
4 10- to 15-minute recess. You may step into the jury room.

5 (Jury exits courtroom.)

6 (Recess had.)
